Corporate funds cannot be used to directly support candidates running for federal office and in most states.

BAYERPAC is bipartisan giving to candidates from both major U.S. parties.

BAYERPAC is fully transparent, legally compliant, and highly successful component of Bayer Corporation's strategy to achieve wise government policy.

99.5

99.5% of BAYERPAC contributions go to candidates' election committees. The other .5% goes to paying bank and registration fees

BAYERPAC was able to contribute over \$250,000 to federal candidates in the last election cycle; but must compete with other PACs in the agricultural & pharmaceutical industry that are much more active (Amgen – over \$1.7 million; Pfizer – over \$1.7 million; Merck – over \$1.2 million; DowDupont \$425,000)
